***Charges for Aylesbury Residents and Non-Residents**

'Residents' refers to those people that live in the Parish of Aylesbury, a map is displayed in the Town Hall outlining the specific boundaries. A resident is defined as somebody who immediately prior to their death, was a resident of the Parish of Aylesbury or who lived in the area for over ten years and moved into a nursing home less than 24 months before their death. Resident fees also apply when a resident purchased burial rights but later moved out of the parish.

'Non-residents' refers to all those living outside of the above definition and thus includes neighbouring parishes e.g. Fairford Leys, Buckingham Park, Watermead, etc.

All fees are double for non-residents except where otherwise specified in the schedule of fees.
